Mr. McMillan,

In a [Globe and Mail article](#) by Steve Chase and Shawn McCarthy, a few weeks ago, your staff was quoted as saying that I "grossly misrepresent" the amount of money going to organizations concerned about oil sands development. It is not my intention to misrepresent. That's why, over the past four and a half years, I have been writing to Tides Canada to attempt to fact-check my analysis and calculations with you.
