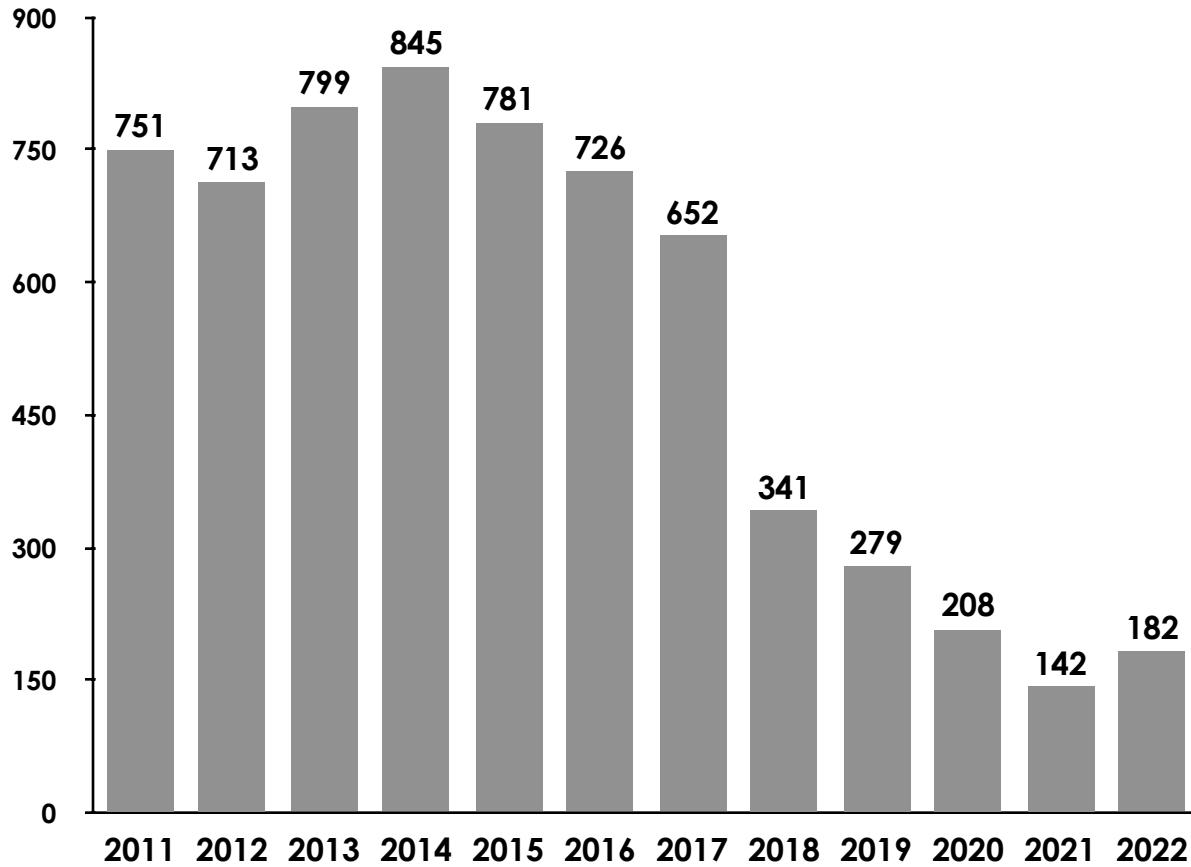

Hello Vivian,

During the 2021-2022 fiscal period, the Canada Revenue Agency (CRA) continued to make use of its risk-based approach to promote and enforce compliance within the charitable sector, through a variety of non-audit interventions in addition to formal audits. Non-audit interventions, which include [Charities Education Program](#) (CEP) visits, education letters and telephone calls, are intended to address lower risk, low complexity non-compliance issues. This allows the CRA to dedicate its audit resources to address the smaller proportion of charities that exhibit the highest risk of more serious non-compliance.

Over the 2021-2022 fiscal period, the CRA completed the following compliance activities:

1. 7,693 non-audit interventions, broken down as follows:
 1. Education letters – 3,749
 2. Educational phone calls – 3,841
 3. CEP visits – 103

2. **182 audits** (139 fields audits and 43 office audits), with the following outcomes:
 1. No changes – 7
 2. Education letters – 81
 3. Compliance agreements – 45
 4. Penalties and/or suspensions – 6
 5. Notices of intention to revoke (NITR) – 28
 6. Voluntary revocations – 5
 7. Annulment – 1
 8. Other (such as pre-registration or revocation tax audits) – 9

Note that the 28 NITRs may include situations where the audit was completed and the CRA proposed to revoke the charity's registration, but has not yet done so because there is a pending objection or appeal.

With respect to the Report on Charities Program for the 2021-2022 fiscal period, the CRA is actively working towards its publication as soon as possible.

Hello Vivian,

As requested, please find attached a table containing the number of completed audits of registered charities for the 2020-2021 fiscal year, as well as the completed audits for the last ten fiscal years.

As you will note, we can confirm that the values you provided are correct, with the exception of the 2017-18 fiscal year, where the value of 548 you provided included both completed audits (341) and non-audit interventions (207). Note that these audit statistics are reported by fiscal year, from April 1st to March 31st.

While you may note a decrease in formal charity audits in recent years, the Canada Revenue Agency (CRA) has actually increased its compliance coverage through other initiatives, such as the Charities Education Program and non-audit interventions, which can include outreach initiative, letter writing campaigns, and automated phone calls.

As you noted, there was a drop in the 2020-2021 numbers because most of our audit activities were put on hold for a period of time due to the COVID-19 pandemic.
