Hello Ms. Yiu/Melody,

We would appreciate your help in arranging an in-person meeting with the Blussons.

As Vivian Krause mentioned in previous correspondence, I was the MLA for West Vancouver Sea-to-Sky when Quest was first conceived. Working closely with David Strangway, President of UBC, I sponsored the Sea to Sky Act in the BC Legislature. This Act created Quest as a degree-granting University.

I have met Stewart and Marilyn Blusson in the past. One event stands out in my memory. After Quest's first convocation ceremony, before a crowd of faculty, students, and friends, and to generous and appreciative applause, Stewart and Marion shared a waltz on the plaza on a beautiful summer afternoon. It was an emotional and touching moment.

Quest's innovative model promised the type of pioneering approach -- breaking new ground, -- that an explorationist and prospector such as Stewart could support. And Quest delivered.

After such an auspicious beginning, it was with great dismay that I watched Quest struggle financially, mystified as to why it was in difficulty, having supposedly received a \$100 million gift from the Blussons.

Vivian Krause, whom I have known and respected for many years, researched the extraordinary background circumstances impacting Quest's financial underpinnings. As a Founder, I followed her step-by-step findings closely. Her forensic reports are thorough and beyond reproach. I understand from the records she has obtained, that Stewart now owns most of the undeveloped land in the vicinity of Quest's original campus.

I would like to speak with Stewart and Marilyn to understand what their plans are for these lands and whether they would consider contributing the land towards a re-start of Quest, possibly as an Institute within Capilano University. This would help perpetuate the original vision which Stewart and Marilyn espoused years ago – a vision remarkably successful, but financially derailed.

I am writing my personal memoirs for publication, describing my twenty years in public life. As former Minister of Advanced Education in the Government, I will describe the Quest story in detail – both its academic success and its financial failure. It will be a no-holds-barred account.

And I would like my memoir to have a happy ending.

I will leave it to Vivian to organize a time when we can meet with Stewart & Marilyn. I look forward to meeting you as well.



Hello Ms. Yiu,

As a long-time resident of Squamish, I have participated in community affairs for many years, and as a citizen was involved in helping Quest University Canada receive its various approvals from city hall. In particular, I helped the university attain the rezoning for the housing subdivisions on the strength the university would sell the individual lots and use the profits to help pay for and fund the university.

I consider myself an early supporter of Dr. Strangway's original vision for Quest University.

I remember when it was announced that Dr. Blusson had donated a very large sum of money to the university (initially announced to be \$65M, then increased), we were all very excited.

To now hear that Dr. Blusson did not actually donate the very large amount (for which he undoubtedly received tax receipts), that there were loans instead of gifts, and that Dr. Blusson is now the owner of two large tracks of Quest's original land, is both puzzling and disturbing, particularly given that the university failed due to a burden of debt. Having contributed to help get Quest started, this is a disappointment to me personally. Even more so though, the closure of the university is a huge tragedy for our community and the students/faculty at Quest, and a lost opportunity for innovative improvement to post-secondary education.

I wish to join Dr. Sultan and Ms. Krause in a meeting with Dr. & Mrs. Blusson to seek ways of recovering the land and make this situation whole again. We must look ahead to the future and find the means to once again restore Dr. Strangway's worthy vision.
