Readers are cautioned that these statements may not be appropriate for their purposes.

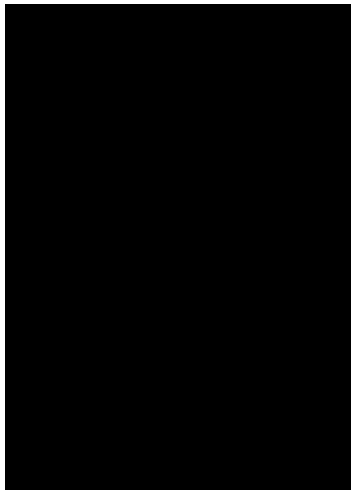
