Attached, please find a revised version of the material that I sent you last week. I would appreciate it if you would please let me know that you have received this e-mail and the attachment.

According to U.S. tax returns, since 1997 the Endswell Foundation has made payments to:

- 1) Interdependent Investments
- 2) Interdependent In
- 3) ILL Ltd.

I happened to notice that for 2004, 2006, 2007 and 2008, some of the amounts that were reportedly paid to Interdependent In. and to ILL Ltd. were identical. This leads me to believe that ILL Ltd. is short for Interdependent In. Is this true? If I don't hear from you to the contrary, I will assume that this is true.

According to my calculations, if Endswell's payments to ILL Ltd. were made to Interdependent Investments Ltd. then the total amount that the Endswell Foundation has paid to Interdependent investments Ltd., since 1997, according to U.S. tax returns, was **SUS1,200,948** - not \$793,298.

In addition to the questions that I asked last week, I would also like to ask what is the total amount that Interdependent Investments Ltd. has contributed to Vision Vancouver? I noticed that according to the most recent disclosure statement for Vision Vancouver, Interdependent Investments Ltd. made another contribution of \$1,000 in June of 2010. Combined with the contribution of \$5,000 in 2008 this would be a total of at least \$6,000. In addition to this, has Interdependent Investments Ltd. made any other contributions to Vision Vancouver - either directly or indirectly?

Since you are one of the directors/officers of Interdependent Investments Ltd., I would also like to inquire as to whether Interdependent Investments Ltd. plans to make any future contributions to Vision Vancouver during the course of the upcoming, pre-election year.

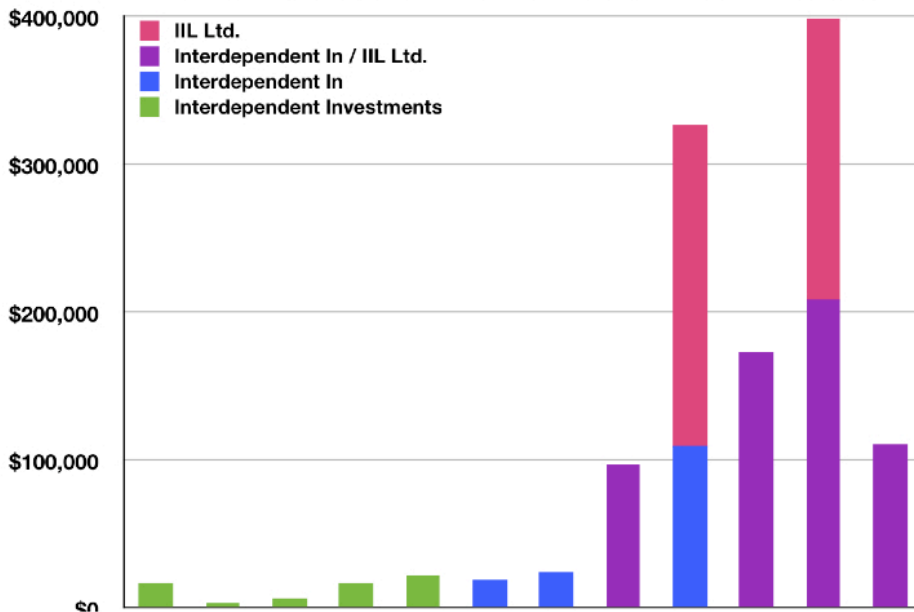

I am writing to introduce myself and to ask questions about a campaign contribution made to Vision Vancouver by Interdependent Investments Ltd.

I notice from on-line information that you are the Treasurer for Vision Vancouver Electors Association. U.S. tax returns for the Endswell Foundation say that you are the Sr. Vice President. A company search (below) says that the directors and officers of Interdependent Investments Ltd.. are Martha Burton and Joel Solomon.

According to the Vancouver Sun's campaign finance database, Vision Vancouver received a contribution of \$5,000 from Interdependent Investments Ltd. My calculations based on U.S. tax returns suggest to me that since 1997, the Endswell Foundation has paid **\$793,298** to Interdependent Investments Ltd.

In light of this information, I would like to know what happens to the money that the Endswell Foundation pays to Interdependent Investments Ltd. Where did the \$793,298 go? I would also like to know what is the origin of the \$5,000 that Interdependent Investments Ltd. contributed to Vision Vancouver. Did that \$5,000 originate from the Endswell Foundation?
