Mr. McMillan,

Recently, I noticed that a number of individuals and companies that are closely affiliated with Tides Canada Foundation seem to have contributed about **\$181,000** to Vision Vancouver and Mayor Gregor Robertson's campaign, as follows:

- Strategic Communications: \$83,314
- Renewal Partners: \$70,629
- Carol Newell: \$15,010
- Joel Solomons: \$9,165
- Drummond Pike: \$2,000
- Bob Penner: \$1,695
- TOTAL +/- related to Tides Canada and the U.S. Tides Foundation: \$181,813

In light of these substantial, financial contributions from individuals who are intimately involved with Tides Canada and that these are donations were made explicitly to influence Vancouver politics, I hope that Tides Canada will not hesitate to fully disclose the organizations and the amounts to whom Tides Canada has re-granted **\$US 43.7 Million** from U.S. sources - including the **\$US 7 Million** to "address" the development of Canada's **oil and gas**.

Mr. McMillan,

I don't seem to have received any communication from you since January.

As you know, I am concerned about the huge amounts of American money that you are re-granting in the name of Tides Canada, and how this hasn't exactly been out in the open.

I am not opposed to American funding. I do believe that it should be disclosed.

My main questions are:

- 1) U.S. tax returns and on-line databases suggest that since 2003/2004, U.S. foundations have granted at least **\$US 43.7 Million** to Tides Canada Foundation. To which B.C. organizations have these U.S. funds been re-granted?

- 2) Who is the "dedicated funder" (see the attached Tides Canada newsletter) who made it possible for Tides Canada to initiate the Coastal Alliance for Aquaculture Reform (CAAR)? Was the "dedicated funder" the David & Lucile Packard Foundation? According to U.S. tax returns, the Packard foundation granted \$346,500 to initiate CAAR in 2002: <http://fairquestions.typepad.com/files/us346500-2.jpg>
- 3) What is the origin of funds that Tides Canada Foundation granted:
  - a) for Alexandra Morton's sea lice research done under the auspices of the University of Alberta?
  - b) for three grants (see below) to Alexandra Morton's non-profit organization, Raincoast Research Society?
  - c) to Simon Fraser University and to UBC, and for what purpose were these funds granted?

According to my calculations, the California-based, David & Lucile Packard Foundation ("Packard") and the Gordon & Betty Moore Foundation ("Moore") have granted about **\$US 88 Million** to organizations operating in British Columbia, including at least \$US 23.3 million to Tides Canada Foundation. I believe that it is particularly fair to ask Tides Canada to identify the recipients of U.S. funds that originated from Packard and Moore. Here's why: Packard implements a "Market Intervention" strategy and, according to my calculations, has granted about \$US 75 million to sway market share towards Alaskan "wild" fish, and away from the competition: imported, farmed fish - especially farmed salmon. Moore funded the co-ordination of an "antifarming campaign" involving "science messages" and "earned media." U.S. tax returns say that the purpose of this campaign was to shift consumers and retailers away from farmed salmon. Both Packard and Moore have heavily funded scientific journals (eg. SCIENCE, PLoS, and Conservation Biology) in which sea lice research is published. At the time that studies of PCBs in farmed salmon were published in the journal SCIENCE, the Editor-in-Chief, Dr Donald Kennedy, was a trustee of the Packard foundation. The current Editor-in-Chief of SCIENCE, Dr. Bruce Alberts, is a trustee of the Moore foundation. If "scientific" studies have been published as part and parcel of the "Market Intervention" strategy of U.S. foundations seeking to protect U.S. trade interests, the public has the right to know.

I do not seem to have received any communication from you since 15 January 2010.

As you know, I am concerned about the "reform" of aquaculture and the lack of transparency in the U.S. funding for this. As I believe that this is a matter of public interest, I am copying this e-mail to the Mayors and Members of Parliament in coastal areas which are affected by the controversy over aquaculture. As I have mentioned before, according to my analysis of U.S. tax returns, American foundations have granted at least \$US 43.7 million to Tides Canada Foundation. Please see: <http://fairquestions.typepad.com/fishfarmfuss/2010/01/tides-canada-43-million.html>

The attached table attempts to list the B.C. environmental organizations and universities (SFU and UBC) that Tides Canada Foundation reports as grant recipients. I compiled this table from information posted at the web-site of Tides Canada: <http://tidescanada.org/about/grant-recipients/>

In general, I am writing to ask Tides Canada Foundation to provide information about to whom funds from U.S. foundations have been re-granted, and for what purpose. As I have asked before, my specific questions include the following:

- 1) Who is the "dedicated funder" (see the attached newsletter from Tides Canada) who made it possible for Tides Canada to initiate the Coastal Alliance for Aquaculture Reform (CAAR)? Was the "dedicated funder" the Packard foundation? According to U.S. tax returns, the Packard foundation granted \$346,500 to initiate CAAR in 2002: <http://fairquestions.typepad.com/files/us346500-2.jpg>
- 2) What is the origin of funds that Tides Canada Foundation granted:
  - a) for sea lice research done under the auspices of the University of Alberta?
  - b) for three grants (see below) to Alexandra Morton's non-profit organization, Raincoast Research Society?
  - c) to Simon Fraser University and to UBC, and, for what purpose were these funds granted?

According to my calculations, the David & Lucile Packard Foundation and the Gordon & Betty Moore Foundation have granted at least \$US 14.1 million and \$US 9.2 million to Tides Canada Foundation, respectively. I believe that its fair to ask Tides Canada to say to whom funds from the Packard foundation, and the Moore foundation, have been re-granted. Here's why: 1) The Packard foundation implements a "Market Intervention" strategy and, according to my calculations, has granted about \$US 75 million to sway the seafood market, especially for salmon. 2) The Gordon & Betty Moore Foundation funded the co-ordination of an "antifarming campaign" involving "science messages" and "earned media" to shift consumer and retailer demand away from farmed salmon. Both the Packard foundation and the Moore foundation have heavily funded scientific journals (eg. SCIENCE, PLoS, and Conservation Biology) in which sea lice research done under the

auspices of the University of Alberta is published. At the time, the Editor-in-Chief of SCIENCE was a trustee of the Packard foundation:

According to Ms. Cummings, these three grants originated from two different sources. In particular, I would like to know whether any of this funding originated with the David & Lucile Packard Foundation. One of the trustees of that foundation was also the Editor-in-Chief of SCIENCE where the sea lice research was publicized. Its fair to ask whether funding for this sea lice research was received from a foundation of which the reviewer was simultaneously a trustee.
