Dear Mayor Hurley,

The purpose of this e-mail is to request confirmation that the attached copy of the payout order for the purchase of Fortius Sport & Health Centre is correct. I would appreciate it if you would please let me know.

By way of background, as your records will show, in January of 2021 I wrote three letters to you with regards to the purchase of Fortius Sport & Health Centre by the City of Burnaby. Later that same year, I was sued by Scott Cousens. Unbeknownst to me at the time, just a few days before Mr. Cousens filed his claim against me, he received an audit report from CRA and was notified that CRA intended to revoke charitable status of Fortius Foundation. Two years later, that became official as of July 29, 2023.

I believe that Mr. Cousens' claim against me is without merit and have filed a motion for dismissal of his claim under the Strategic Litigation Against Public Participation Act.

As part of the proceedings, I received a copy (attached) of the pay out order for the sports centre. I would appreciate it if you would please ask someone from your staff to verify that this payout order is correct.

I have also attached a copy of the two affidavits that I have filed in this matter. Also attached is an affidavit provided by Stewart Irvine, the founder of Global Charity Fund which is the origin of the "debt" that Fortius purportedly had, and which apparently necessitated the sale of the sports centre to the City. Once you have had a chance to take read these documents, I would appreciate the opportunity to speak with you.
