Hi Vivian,

In accordance with the disclosure provision of the Income Tax Act that relate to the revocation of a charity's registration, specifically paragraph 241(3.2)(e), the Canada Revenue Agency (CRA) can provide "the entirety of or any part of any letter(s)" that explain the CRA's grounds for revoking the charity's registration. In practice, that provision is applied by disclosing the Notice of Intention to Revoke (NITR) and any attachments that are explicitly identified in the NITR itself. Any other correspondence relating the audit or revocation that is not listed as an attachment to the NITR is therefore considered confidential. The documents that are included as attachments to an NITR may therefore vary and are evaluated on a case-by-case basis.

Given the above considerations, beyond providing the NITR that we previously submitted to you for Association for the Advancement of Scholarship, we have reviewed our records and can confirm that we have no further documents to provide.

As you noted, the NITR was sent to the Organization on August 2, 2013. While the confidentiality provisions of the Act do not allow us to provide any further details with respect to the revocation timeline, we can confirm that the Organization's registration as a registered charity was revoked by the CRA following normal administrative procedures.
