

Likewise, the value of the 60 acres in Squamish (PID 027-314-685) registered to Global Charity Fund was \$20,125,000 in 2022 and \$29,400,000 in 2021.

Management is of the opinion that the transfer value approximates fair market value.

(b) Disposition by gift

On December 30, 2015 the above parcels of land were transferred to the Chimp: Charitable Impact Foundation at an agreed transfer value of \$28,037,500 in aggregate, by deed of gift. No donation receipts were issued by the Foundation and further, no actual detailed property appraisals were undertaken at the transfer date. External real estate broker guidance provided to Management confirmed the transfer value as approximating fair market value.

#### 4. Notes payable

The Foundation has a non-interest bearing note payable with no fixed terms of repayment of \$ 622,161 (2016 - \$ Nil) and a note payable of \$ 660,387 (2016 - \$ Nil) bearing interest at a fixed rate of 4.00% per annum and maturing on December 23, 2019.

#### 5. Related party transactions

#### 6. Financial instruments

Financial instruments consist of cash, cash surrender value of life insurance, GST/HST payable and notes payable.

##### Interest rate risk

The notes payable bears interest at fixed rates and therefore do not expose the Foundation to interest rate risk.

##### Credit risk

Cash is exposed to credit risk due to the potential for counterparties to default on their contractual obligations.

The Foundation estimates its maximum credit risk for cash at the amount recorded on the balance sheet.
